Who Can Enter

U.S. residents 18 years or older are eligible to enter. The Senior Resource Association reserves the right to limit the number of tickets distributed to each individual. Tickets are non-transferable, non-negotiable, and non-assignable. The raffle closes at 12:00 p.m. on Monday, March 23, 2026.

To enter without a donation:

(1) email your request to events@sramail.org, then (2) print your name, address, phone number and email address along with a handwritten statement that you wish to obtain a "no-donation" raffle ticket entry, (3) mail the above to Senior Resource Association Foundation, Attn: SRA's 21st Grand Safari Experience Raffle, 694 14st Street, Vero Beach, FL 32960. Only one no-donation entry will be accepted per name, mailing address or email address. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Senior Resource Association Foundation.
